Safe Travel for All Children: Transporting Children with Special Health Care Needs

is designed to serve as an enrichment course for child passenger safety technicians who are interested in learning more about special needs transportation. The training, which lasts approximately two days, combines classroom lectures, discussions, and hands-on exercises including an opportunity to interact with families. During the training, participants will be introduced to medical conditions that can impact restraint selection and have the opportunity to investigate and install specialized restraint systems. The training includes proficiency check-offs that evaluate the student's ability to assess appropriate restraints and to demonstrate proper use and installation.



To complete this enrichment training, participants must be certified child passenger safety technicians. This course builds on that basic knowledge. This course qualifies for 6 CPST CEUs.

## **Objectives**

- Identify considerations for transporting premature and low birth weight infants and performance of Car Seat Challenge Testing.
- Describe use and installation procedures for car beds, vests, harnesses, & large medical seats.
- Identify specific types of misuse unique to positioning children in and installing specialized restraints.
- Describe restraint systems designed specifically for use on school buses.
- Perform installation of the following on ambulance cots: convertible seat, car bed, and transport system.
- Assess a child's restraint needs during a family visit.
- · Identify local resources to assist families.

### Who should take this course?

Child passenger safety technicians that work with children with special health care needs including NICU staff working with premature babies, OT/PT in clinics or the school system, nurses or discharge staff in hospitals, CPST instructors wanting to expand their knowledge, DME vendors, pediatricians, school bus drivers, ER/EMS staff, and Head Start staff.

### **Definition**

Children with special health care needs are those who have or are at increased risk for a chronic physical, developmental, behavioral, or emotional conditions and who require health and services of a type or amount beyond that required by children generally.
