#### **Press Hard, Five Copies!**

Enforcement of Colorado's enhanced car seat law starts August 1, 2011. The law requires children to ride in child restraints (typically booster seats) up to age 8.

Also, in the 2011 legislative session, the lap-only seat belt exemption was removed from the child restraint law, effective July 1, 2011 (now!). Prior to that, children were exempt from the booster seat requirement if there were only lap belts available in their vehicle.

If lap-only seat belts are the only option, then that child typically must be restrained in a harnessed car seat which is rated to a higher weight limit (one that would accommodate them up to age 8). There are many mainstream car seats on the market that have harnesses rated up to 50, 60 and even 80 lbs.
