NHTSA Region 8 Update:

- Joe Livingston, NHTSA Program Manager, Region 8:
 - NHTSA is making funding available through DUID tool to assist State, local, territorial, and tribal government with assessing and strengthening drug-impaired driving program.

- Safe Streets and Roads for All (SS4A) funding opportunity available to counties, cities, municipalities, etc. to apply for a wide range of activities, including the development of a Comprehensive Safety Action Plan or Action Plan. The program covers activities such as traffic safety engineering solutions to behavior safety interventions (e.g., Vision Zero plans).
- The 2022 ABA National Traffic Academy conference in Denver, CO June 13-15, 2022 will provide educational programming and resources to judges, judicial officers, prosecutors, and defense attorneys to help improve traffic court operations.

Statistics, State Fatality Numbers:

- Sarah Barkley, CDPHE - presented Motor Vehicle Fatalities as of May 10, 2022. 186 fatal crashes with 204 fatalities, with over 35% of those suspected to be due to impaired drivers. 24% of fatalities were related to speeding. 51% of total occupant vehicle fatalities were unrestrained. The age group of 35-44 had a significantly higher percentage (52%) of suspected impaired compared to other group ages. Additionally, the data reveals that high suspected impaired fatal crashes occurs between 2:00a.m. - 5:59a.m.
- Dr. Cindy Stewart, CSP - shared Impaired Driving Citations and Impaired Crashes data. The March 2022 report shows a total 385 DUI/D Citation issued in March and 4 years average of 384. The report also breaks down the DUI/D Citation issued by drug type category, with 26 citations for Marijuana only. A total of 1100 DUI/D Citation were issued from January - March 2022. This year the data reported 13 Fatal Alcohol and Drug Caused Crashes.

Legislative Updates

- Tuesday Black, Vice Chair:
 - Suggested to create an electronic directory that will help identify and share knowledge & expertise in the task force. The directory will include: headshot of the individual, title, contact information and summary of the programs/services provided. The targeted date to finalize the directory is August 19, 2022.
 - Prepares a collaborative effectiveness survey to explore new areas of expertise where the task force could add more focus on.
 - Suggested to host the task force in-person meetings throughout Colorado to

benefit other regions as they physically participate in meetings. The virtual meeting option will remain available for participants who cannot travel.

- Legislation:
 - SB22-055 Alcohol Monitoring For Impaired Driving Offenders passes 96-0 (<http://leg.colorado.gov/bills/sb22-055>).
 - HB22-1142 to allow cities to extend bar hours failed in House Business (<http://leg.colorado.gov/bills/hb22-1142>).
 - \$1.5 million in High Visibility DUI Enforcement Funding confirmed in FY2023 budget.
 - HB22-1321 Study Of Devices Assessing Motorist Impairment passed (<http://leg.colorado.gov/bills/hb22-1321>).
 - HB22-1417 Alcohol Beverages Task Force And Retailer Licenses passed House but failed in Senate (<https://leg.colorado.gov/bills/hb22-1417>).
 - Crime Victim Services funding bill passed with \$38 million to fill \$41 million shortfall in 2023-2024 (<http://leg.colorado.gov/bills/sb22-183>).
 - Updates to Victim Rights Act passed (<http://leg.colorado.gov/bills/sb22-049>).
 - SB22-175 Mobile Electronic Devices And Motor Vehicle Driving passed the Senate but failed in the House.

- Samuel Cole, CDOT/Office of Communications:
 - CDOT launched education series targeting employees of dispensaries.
 - Kick off of alcohol awareness campaign to raise awareness over the next enforcement period, around Memorial weekend.
 - New partnership with Anheuser-Bush, MADD and Uber. Decide to Ride campaign will be launched throughout the Summer to get people to plan ahead and use rideshares.
 - Traffic Safety Summit July 18-20, 2022 in Loveland, CO (no registration fee).
