Statistics, State Fatality Numbers:

- Rachel Reinhart, CDSP:
 - Colorado State Patrol, Vehicular Crimes Analysis Unit (VCAU) January 1st to October 31st, 2023. Impaired Driving Crashes and Impaired Citations Update
- Crystal Soderman, DOR (Refusals):
 - o 108 days on average to get blood test backs, data 4 months lag right now.
 - Express Consent Stats given.
- Sam Cole, CDOT:
 - Committee taking a pause on the committee to regroup and will give full Presentation in January 2024
 - Paused Law Enforcement Survey
 - Offenders survey is out.
- Tuesday Black, CDOT:
 - Received some feedback from State Patrol on Survey and idea was to spread to all Law Enforcement outside State Patrol
- Josh Downing, CSP:
 - Typically, don't send out surveys to Troopers, get information through first line supervisors.
 - Several questions on survey and try to understand information we are getting from survey and questions and not putting Trooper in a position to speculate or conjecture or not know the information.
 - Tuesday Black:
 - Is it the approach that the department to cause a higher rate of refusals, would be nice to identify model officers.
 - Intent was to learn on how Officer's getting trained on SFST's.
 - Intent was to learn from each other.
 - Sam Cole:
 - Take a fresh look at approach.
 - Josh Downing:

- Surveys might not be the correct way to gather information—trainings or at classes or Academy's or DA's what they are seeing in Case reports.
- Tuesday Black:
 - Maybe have Mark, Crystal, Jen involved.
 - Determine what is the intent of this and narrow it down.
- Ed Wood:
 - Question on data points, lag time 108 days verses lag time from report showing 25 days?
 - Josh Downing: Staffing shortage and issue at Lab, speculate that it is a temporary slowdown.
- Jen Knudsen:
 - Built into standard curricula, built into most of our training, in the State of CO no required advisement, do need to very careful moving forward and does cause litigation.
 - Data—the outcomes of the DMV hearings would be very interesting?
 - Need be very careful what we are asking our Officers to say to Defendants.
- Scott Pearson:
 - Developing conversation and skills for Officers
 - How important the work is and bringing it to the Training.
- Crystal Soderman:
 - Address Jen's question, Outcomes of hearings of the last calendar year can be sent out, how many upheld verses how many dismissed.

 - Huge cut to funding 41% cut for Federal, working with a lot of other victim services organizations and working with Congress to act.
