II. Implementation and Evaluation of a Motivational Supplement to Colorado's Ignition Interlock Program.

a. Presented by Dr. David Timken, Center for Impaired Driving Research and Evaluation

The study will be conducted by the Pacific Institute for Research and Evaluation (PIRE), Calverton, MD. The target population is Persistent Drunk Drivers. This evaluation take a random assignment study of a motivational intervention and planning supplement for DUI offenders who are required to drive with an Ignition Interlock system installed in their vehicle.

a. Herman Stockinger, CDOT Legislative Liaison gave an overview of DUI- related Legislation.

HB-1071. Sponsor Representative Rose. "Concerning notice on driver's license that a person has committed certain alcohol-related driving offenses."

HB-1166. Sponsor Representative Judd, Senator Hagedorn. "Cleanup of the DUI statutes that was discussed by the DUI Task Force."

HB-1194. Representative Judd, Senator Veigg. "Concerning measures by executive branch agencies to reduce the incidents of drunk driving."

SB-031. Sen. Shaffer, Rep. Fischer. "Concerning criminal offenses involving motor vehicles".

SB-076. Sen. Renfroe, Rep. Lambert. "Concerning bail for a person charged with certain alcohol or drug-related driving offenses even if the person is given a summons.

Herman has agreed to send out DUI-Related Legislation during the legislative session.
