



All Flagger Instructors training and certifying flaggers in/for Colorado shall be employed by a CDOT certified Flagger Training Entity. All Flagger Instructors shall complete, sign, date, and submit this Flagger Instructor Agreement along with copies of their current flagger instructor certification and current flagger certification upon application for certification and recertification as a CDOT approved Flagger Instructor. The CDOT Flagger Program manager will review and approve or deny the Flagger Instructor Agreement. CDOT will give notice to the applicant if their Flagger Instructor Agreement is denied or will provide a copy of the approved Flagger Instructor Agreement to the applicant and Entity. Because Flagger Instructors must obtain and maintain a valid Flagger certification, all Flagger Instructors must be at least 18 years of age per CRS 43-5-308.

As a CDOT approved Flagger Instructor I affirm that I will:

- Adhere to the most recent versions of the CDOT Flagger Program requirements per the *CDOT Flagger Entity Terms and Conditions, CDOT Flagger Entity Certification Application*, industry memos, and all other rules and methods disseminated by the CDOT Flagger Program.
- Provide CDOT notice on all pre-planned flagger class locations, dates, and times.
- Conduct at least one flagger training and certification course per year.
- Use current versions of the CDOT approved flagger training and testing materials (which includes CDOT, ATSSA, or NSC) when conducting classes.
- Be physically present throughout the entire Flagger written and practical examination processes.
- Provide MUTCD compliant flagging equipment for classes.
- Conduct yourself in an ethical and professional manner.
- Be courteous to and accommodating of students.
- Understand temporary traffic control and flagging techniques and procedures.
- Maintain a valid CDOT or CDOT approved Flagger Instructor certification.
- Maintain a valid Flagger Certification obtained through a CDOT approved Flagger Training Entity.
